- Planning on distributing 750 school backpacks during their backpack drive, which is an increase from last year.
- Providing bicycles through donations to families and children
- They serve 1 out of 8 families and children

Buckeye Health Plan (Marriah Kornowa & Mike Hibbard)

- Currently working remotely until atleast August/September
- Providing telephonic support for clients
- Currently held a Virtual Baby Shower for clients
- Were able to secure money for Toledo for food and supplies for individuals in need due to COVID

TLCHD/Maternal Health (Melissa Hallenbeck)

- Currently in working in the office
- Works on 4 grants: 2 safe sleep grants, and 2 Workplace Wellness grants



- Safe Sleep education for qualified individuals are currently available online with cribs being shipped to the individual
- Starting soon, the cribs will need to be picked up at the HD
- Currently has one more spot open for a worksite with less than 50 employees to partake in the worksite wellness grant. Has funding to provide worksite with policy and supplies

i. Active Living

a. Lucas County Active Transportation Plan

- Working on a county-wide ATP
- Group has recently met to define the scope, vision, mission and goals of the proposed ATP
- Interested being on the ATP steering committee, please contact Amy

b. Inclusive Playgrounds

- Working with Lucas County Children Services on renovating their 25yr old playground to become disability inclusive
- > Playground was originally a bank courtyard
- > Will be used as a meeting place for family visits
- The playground renovation project is a community project encompassing many different organizations
- > 2020 will include the pre-site prep work
- > Summer of 2021 will be the grand opening of the newly renovated playground
- > Anyone interested in being a partner on this project, please reach out.

c. Washington Local Safe Routes to School

- Washington Local Safe Routes to School Travel Plan was completed and submitted in March of 2020
- WLS was awarded a 400K in infrastructure funding and 20K in non-infrastructure funding
- The infrastructure funding will be used for sidewalks, crosswalks.
- Federal Funding from Toledo PSIP will also be used for SRTS infrastructure changes



- Non-infrastructure funding will be used for education strategies. Strategies include adult and student crossing guard trainings, safe routes to walk to and from school, speed feedback signage, educational toolkits, etc.
- > Funding was also received from Toledo Community Foundation.
- Waiting to apply for Action for Healthy Kids-applications has been delayed until August due to COVID
- Toledo Public Schools Safe Routes to School also received 30K in noninfrastructure funding.

ii. Healthy Eating

a. Client Choice Food Pantry

- Working with OSU extension and Live Well Greater Toledo in developing a Client Choice Food Pantry Toolkit
- Plan to reach out to area food pantries this summer to discuss converting to a Client Choice pantry

b. Farmers Market

- Will be hosting pop-up farmers' markets the 3rd Tuesday of the month July-October from 11-2
- Locations of farmers' markets include: July: Eleanor Kahle Senior Center, August: Toledo Lucas County Health Department, September: TBD, October: East Toledo Family Center
- SNAP, Produce Perks, WIC Farmers Market vouchers, Senior Nutrition Coupons and cash will be accepted
- > Same 2 farmers from last year will be the vendors
- > All social distancing procedures will be followed
- Marketing for farmers' markets are being developed. Once developed it will be sent out
- WIC staff will be at the events to help pass out WIC farmers' market coupons to clients
- > Produce Perks will be at some of the markets signing people up for their program
- If interested in providing resources for the farmers' market to pass out at the event, please contact Amy

c. Food and Beverage Guidelines

- Currently working with the YMCA on reviewing current food and beverage guidelines for their childcare services
- Working to adopt an official policy
