Local Surveillance:

Current Influenza Activity Levels:

Lucas County had **20** confirmed Influenza-associated Hospitalizations (IAH) reported in week 15, bringing the total to **677** cases as of April 14, 2018. *83% of cases are flu type A, 92 were H3 strain-the majority were not subtyped.*

--There were no deaths reported


Gender Distribution of Cases: 55% female, 45% male

Lucas County accounts for 4.1% of the IAH reported in Ohio. Rate per 100,000 population**: 151.87

**Disease rates were calculated by number of cases per 100,000 residents using 2010 census data





The number of emergency department visits with patients exhibiting fever/ILI symptoms was right around baseline for MMWR 15. ILI (Influenza-Like Illness) is defined as a *fever greater than or equal to 100 degrees F AND a cough or sore throat*. (Graph 3)



Summary of State Data: Current Ohio Activity Level (Geographic Spread) – Regional

Definition: Increased ILI in > 2 but less than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions, OR institutional outbreaks (ILI or lab confirmed) in > 2 but less than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions.

Toledo-Lucas County Health Department Seasonal Influenza Activity Summary MMWR Week 15 April 8-14, 2018

During MMWR Week 15, public health surveillance data sources indicate decreased influenza-like illness (ILI) activity in outpatient settings reported by Ohio's sentinel ILINet providers. Outpatient medical claims related to influenza-like illness also decreased during MMWR Week 15. The percentage of emergency department visits with patients exhibiting constitutional symptoms and ILI specified ED visits decreased as well. Reported cases of influenza-associated hospitalizations are above the seasonal threshold* with 365 influenza-associated hospitalizations reported during MMWR Week 15.

State Surveillance:

- ODH lab has reported 1188 influenza tests from specimens sent from various submitters. 2017-2018 influenza season positive results: (683) A/H3N2; (104) A/pdmH1N1; (195) Influenza B; (through 04/14/2018).
- The National Respiratory and Enteric Virus Surveillance System (NREVSS) has reported 74,291 influenza tests performed at participating facilities. 2017-2018 influenza season positive results: (195) H1N1, (636) A/H3N2, (11,199) Flu A Not Subtyped, and (4107) Flu B (through 04/14/2018).
- 4 pediatric influenza-associated mortalities have been reported during the 2017-2018 season (through 04/14/2018).
- No novel influenza A virus infections have been reported during the 2017-2018 season (through 04/14/2018).
- Incidence of confirmed influenza-associated hospitalizations in 2017-2018 season = 16,565* (through 04/14/2018).

Regional Surveillance*: During week 14 (April 1st – April 7th, 2018), the proportion of outpatient visits for ILI in Region 5 (Ohio is in Region 5) was 1.95%, which is above the regional baseline of 1.8%. Ohio reports Widespread Activity (Regional for Week 15); Kentucky, Michigan, and Pennsylvania reported Regional Activity; and Indiana and West Virginia reported Local Activity.

National Surveillance*: During week 14 (April 1st – April 7th, 2018), most U.S. states reported Minimal or Low influenza activity, though a few are still reporting Moderate or High activity. The proportion of outpatient visits for ILI was 2.1%, which is below the national baseline of 2.2%. Six of 10 regions reported ILI at or above their region-specific baseline level. The most frequently identified influenza virus type reported by public health laboratories was influenza B.

*Regional and National surveillance data are reported one week later than Ohio state and local data
