Local Surveillance:

Current Influenza Activity Levels:

Lucas County had **1** confirmed Influenza-associated Hospitalizations (IAH) reported in week 46, bringing the total to **6** cases as of November 17, 2018. 83% of cases are flu type A.

--There were no deaths* reported


Gender Distribution of Cases: 67% female, 33% male

Lucas County accounts for 7.0% of the IAH reported in Ohio. Rate per 100,000 population**: 1.36

**Disease rates were calculated by number of cases per 100,000 residents using 2010 census data





MMWR Week 46 November 11-17, 2018



The number of emergency department visits with patients exhibiting fever/ILI symptoms was slightly above baseline for MMWR 46. ILI (Influenza-Like Illness) is defined as a *fever greater than or equal to 100 degrees F AND a cough or sore throat*. (Graph 3)



Summary of State Data: Current Ohio Activity Level (Geographic Spread) - Local

Definition: Increased ILI in 1 region; ILI activity in other regions is not increased AND recent (within the past 3 weeks) lab evidence of influenza in region with increased ILI, OR 2 or more institutional outbreaks (ILI or lab confirmed) in 1 region; ILI activity in other regions is not increased AND recent (within the past 3 weeks) lab evidence of influenza in region with the outbreaks; virus activity is no greater than sporadic in other regions.

Toledo-Lucas County Health Department Seasonal Influenza Activity Summary <u>MMWR Week 46 November 11-17, 2018</u>

During MMWR Week 46, public health surveillance data sources indicate minimal intensity for influenza-like illness (ILI) in outpatient settings reported by Ohio's sentinel providers. The percentage of emergency department visits with patients exhibiting constitutional symptoms are slightly above baseline levels statewide; fever and ILI specified ED visits are below baseline levels. Reported cases of influenza-associated hospitalizations are below the seasonal threshold*. There were 20 influenza-associated hospitalizations reported during MMWR Week 46

State Surveillance:

- ODH lab has reported 11 positive influenza tests from specimens sent from various submitters. 2018-2019 influenza season results: (10) A/pdmH1N1; (0) A/H3N2; (1) Influenza B; (through 11/17/2018).
- The National Respiratory and Enteric Virus Surveillance System (NREVSS) has reported 10,099 influenza tests performed at participating facilities. 2018-2019 influenza season positive results: (2) A/pdmH1N1, (0) A/H3N2, (39) Flu A Not Subtyped, and (14) Flu B (through 11/17/2018).
- 0 pediatric influenza-associated mortalities have been reported during the 2018-2019 season (through 11/17/2018).
- No novel influenza A virus infections have been reported during the 2018-2019 season (through 11/17/2018).
- Incidence of confirmed influenza-associated hospitalizations in 2018-2019 season = 86 (through 11/17/2018).

Regional Surveillance*: During week 45 (November 4th – November 10th, 2018), the proportion of outpatient visits for ILI in Region 5 (Ohio is in Region 5) was 1.2%, which is below the regional baseline of 1.8%. Ohio, Pennsylvania, Indiana, West Virginia, and Michigan reported Sporadic Activity. Kentucky reported Regional Activity.

National Surveillance*: During week 45 (November 4th – November 10th, 2018), the majority of U.S. states reported Minimal influenza activity; a few states are reporting Low or Moderate activity. The proportion of outpatient visits for ILI was 1.9%, which is below the national baseline of 2.2%. One of 10 regions reported ILI at or above their region-specific baseline level. The most frequently identified influenza virus type reported by public health laboratories was influenza A (H1N1).

*Regional and National surveillance data are reported one week later than Ohio state and local data
