I. Call to Order and Roll Call

II. Introduction of Guests

VI. Legal Update – Kevin Pituch

• The lead ordinance was challenged in court on November 1, 2023, and the judge ruled the ordinance is fine thus rejecting the challenge to it. The ordinance is constitutional,

and the city can enforce it. The order has been challenged on appeal, and we will know the result next summer.

- Some laws are perhaps questionably constitutional. Kevin Pituch advised the board to act in the public health's interest.
- ORC 3707.26 (Board shall inspect schools and may close them.) language has been amended.
- ORC 3707.11 (Application of quarantine or isolation orders.) limits the Board of Health's authority.

VII. Medical Director's Report – Megan Lutz, MD

Angie Bauman reported a comprehensive site visit for the Reproductive Health Clinic
was conducted on Tuesday, November 14, 2023. The survey was done by the Ohio
Department of Health's Title X grant staff. They will come back for more technical site
visits in the next couple of years, and a comprehensive site visit will be done in four
years.

(Resolution 311-23) A motion was made by Matthew Sapara and seconded by Dr. Munk to approve the payment of the October 2023 Vouchers. Motion carried; 11 Yeas, 0 Nays.

(Resolution 312-23) A motion was made by Dr. Ross and seconded by Dr. Munk to approve the changes in revenue estimates and expense appropriations of \$62,448.93 for October 2023. Motion carried; 11 Yeas, O Nays.

(Resolution 313-23) A motion was made by Matthew Sapara and seconded by Susan Postal to apply for and accept, if awarded, Reproductive Health and Wellness Program. Motion carried; 11 Yeas, 0 Nays.

(Resolution 314-23) A motion was made by Barbara Sarantou and seconded by Dr. Woodson to apply for and accept, if awarded, Ohio Equity Institute. Motion carried; 11 Yeas, 0 Nays.

(Resolution 315-23) A motion was made by Dr. Munk and seconded by Sue Postal to apply for and accept, if awarded, Early Intervention Services. Motion carried; 11 Yeas, 0 Nays.

(Resolution 316-23) A motion was made by Dr. Munk and seconded by Sue Postal to Enter into Agreement with Toledo Walleye to provide traffic safety awareness opportunities. Motion carried; 11 Yeas, 0 Nays.

(Resolution 317-23) A motion was made by Dr. Munk and seconded by Sue Postal to Enter into Agreement with the University of Toledo to provide a forum for clinician-to-clinician consultation to improve the health outcomes in congenital syphilis. Motion carried; 11 Yeas, 0 Nays.

(Resolution 318-23) A motion was made by Dr. Munk and seconded by Dr. Woodson to enter into Contract with the City of Toledo to perform the duties listed in Chapter 1760 of the Toledo Municipal Code to help prevent lead poisoning of our residents and will enforce its requirements on Residential Rental Properties and Family Child Care Homes. Motion carried; 11 Yeas, 0 Nays.

(Resolution 319-23) A motion was made by Matthew Sapara and seconded by Dr. Munk to enter into Agreement Addendum with Anthem Blue Cross & Blue Shield in regards to the limited terms and conditions governing the provision of and payments for health services provided to Medicaid members. Motion carried; 11 Yeas, 0 Nays.

(Resolution 320-23) A motion was made by Dr. Ross and seconded by Dr. Munk to approve the Write-Off of Uncollectable Amounts that are for dates of services at least 180 days or older. Total amount is \$1484.07 for the month of October. Motion carried; 11 Yeas, 0 Nays.

(Resolution 321-23) A motion was made by Dr. Munk and seconded by Susan Postal to approve the Audit/Finance Committee Report. Motion carried; 11 Yeas, 0 Nays.

(Resolution 323-23) A motion was made by Dr. Ross and seconded by Dr. Munk amend the bylaws, under ARTICLE IV: ROLES AND RESPONSIBILITIES

Each BOH member must complete two hours of continuing education annually. Each continuing education credit shall pertain to one or more of the following topics: ethics, public health principles, and a member's responsibilities, pursuant to OAC 3701-36-03 and ORC 3701.342. Motion carried; 11 Yeas, 0 Nays.

(Resolution 324-23) A motion was made by Dr. Ross and seconded by Matthew Sapara to approve the Bylaws and Governance Committee Report. Motion carried; 11 Yeas, 0 Nays.

G. Health Services Committee – Dr. Johnathon Ross

Committee did not meet in November.

H. Facilities and Fleet Committee – David Karmol

Committee did not meet in November.

IX. Prior Business

 Dr. Ross brought up traffic safety on scooters. There really is no safety policy for scooters, and the number of injuries have increased. We should ask our staff who deals with traffic safety to research what is being done in other localities for injury prevention.

position. Waverly Partners has posted the job position. Paul and some board members
have been in contact with stakeholders for hospitals, doctor's offices, the county, the
