- Collaborated with the Robert Wood Johnson Foundation and RAND Corporation surrounding the Sentinel Communities Surveillance Project, focusing on improving health, equity, and well-being for residents. (Toledo is one of 30 communities across the U.S. chosen for this project's 10-year effort to build a culture of health in America in 2016, and the only city in Ohio.) (See Page 28)
- Implemented the Public Health Speakers Bureau, promoting public health education through TLCHD's knowledgeable and highly educated staff.
- Established Lucas County's first Stock Albuterol Program in Toledo Public, and Washington Local Schools. (See Page 12).
- Our commitment to professional development was evident as staff obtained additional licensures, credentials, and received over \$30,000 tuition reimbursement to pursue advanced degrees.
- We also participated in various conferences and trainings such as NACCHO 360, Opioid Fatality Review National Forum, TechCred, and piloted a new Learning Management System, Tovuti.

Thank you to all those who tirelessly work towards the betterment of public health along with unwavering dedication to the health of our community. Together, we possess the ability to surmount any obstacles and forge a healthier, more resilient future for forthcoming generations. As we work to continually improve our organizational culture and our capacity to serve our community, this report serves as an opportunity to acknowledge and celebrate the hard work of our programs and staff striving to achieve our goal of optimal health and well-being for the Lucas County community.

# **COMMUNITY RESPONSE & PREPAREDNESS**

In 2023, TLCHD's Public Health Emergency Preparedness (PHEP) staff engaged in exercises, workshops, and response efforts to enhance emergency preparedness efforts and community resilience.

#### **Key Highlights:**

- Davis-Besse functional exercises with FEMA and local response agencies to test Lucas County's radiological plans and response capabilities;
- The annual Ohio integrated Preparedness Planning Workshop to collaborate with local hospitals and health departments to discuss capabilities, priorities, training schedules and information sharing;
- An after-action response meeting with local partners to review the response and recovery from the June 15 tornado in Point Place;
- The Ohio Department of Health's Medical Countermeasures (MCM) Full-Scale exercise to test TLCHD's ability to respond to a biological incident, disseminate internal and external emergency notifications, communicate with partners, and collaborate with hospitals to coordinate distribution of prophylactic medications.

More than 10,000 COVID-19 test kits distributed to community partners and residents in Lucas County.

The State of Ohio recognizes more than 88 diseases and infectious agents that pose a severe threat to public health

- Lucas County epidemiologists responded to 1 or more cases of 34 Class A, B, C reportable diseasees in 2023.
- In the last 5 years, TLCHD has responded to 1 or more cases of 48 reportable diseases.




# **VITAL STATISTICS**

Birth and death data is reported for all individuals who are Lucas County residents and does not include residents of other jurisdictions who were born or died within Lucas County. The 5-year top ten causes of death chart illustrates the continued impact of heart disease and cancer on our community. Other causes, such as chronic lung disease, cerebrovascular diseases/stroke, diabetes, and chronic liver diseases/cirrhosis are all on the relative-rise year to year. COVID-19 deaths have dropped dramatically by 90% of their toll from the first 2 years of the pandemic, illustrating the impact of public health's prevention, mitigation, and vaccination efforts.



2023 Total Deaths All Causes: 4,275


### 5 Year Top 10 Causes of Death for Lucas County Residents




# **FETAL AND INFANT MORTALITY**

Fetal mortality and infant mortality rates are important metrics used in public health to better understand and track the health of populations, particularly with regards to pregnancy and early childhood.

These rates are critical for understanding the health status of mothers, infants, and populations as a whole. The data identifies areas for improvement, interventions, and monitors progress in reducing preventable deaths during pregnancy and early childhood.



The number of fetal deaths **decreased 22.2%** to 28 in 2023 from 36 in 2022.




#### **Infant Mortality**


Infant mortality is the death of an infant before its first birthday. The infant mortality rate is the number of infant deaths per 1,000 live births. There is a noticeable upward trend in Infant Mortality Rate (IMR) within Lucas County in the past decade. In 2023, the infant mortality rose to 11.5 from 9.0 in 2022. Non-Hispanic Black infants die at a rate almost three times higher than that of Non-Hispanic White infants.

**Programs that address Fetal & Infant Mortality** WIC, Healthy Start, Cribs4Kids, OEI


#### Leading causes of infant deaths, Lucas County 2023\*



# Non-Hispanic Black Infants are 2.8x more likely to die than Non-Hispanic White Infants.




# Non-Hispanic Black Women are 1.7x more likely to experience preterm births compared to Non-Hispanic White Women.




# **OHIO EQUITY INITIATIVE**

Ohio Equity Initiative (OEI) (formerly known as Ohio Equity Institute) is a multifaceted grant funded through the Ohio Department of Health with the goal of reducing infant mortality and eliminating racial disparities. Infant mortality is a complex issue, requiring action from multiple angles and areas. Facets of the grant include organizational health equity, data analysis, Fetal Infant Mortality Review (FIMR), Policy/Practice Change, and Healthcare Navigation Services.




#### Race of OEI Clients 2023

# MINORITY HEALTH

Minority Health is an important aspect of public health that focuses on the health outcomes and inequalities experienced by racial and ethnic populations. Efforts in this area aim to understand, address, and eliminate health disparities that exist among these groups compared to the majority population.


TLCHD's Office on Minority Health hosted a number of events in honor of Minority Health Month in April, including a Minority Health Expo, Community Wellness Celebration, a patient advocacy event, and assisted community partners with National Night Out, resource fairs, and other events.





# **OVERDOSE PREVENTION**

Overdose prevention is a critical aspect of public health and harm reduction efforts, and involves community education and training on how to recognize and respond to an overdose. Fentanyl and the opioid crisis still continue to impact Lucas County. In 2022, fentanyl was responsible for 95% of opioid fatalities. However, through the work of TLCHD's Overdose Prevention efforts, overdose numbers are beginning to decline.





Our Overdose Prevention team performed 166 detailed community trainings and 105 street outreach events.

# **NOSS (NORTHWEST OHIO SYRINGE SERVICES)**

In 2023, NOSS was **awarded the Urban Syringe Service Program of the Year** by Harm Reduction Ohio and celebrated 6 years of Syringe Services in Lucas County. NOSS began distributing Xylazine Test Strips and expanded to a new mobile clinic site at Pinnacle (Toledo Treatment).

# **TRAFFIC SAFETY**

**260** serious injury and fatal crashes occurred in Lucas County throughout 2023.

#### **Top Timing Statistics:**

- More serious/fatal crashes occured on Fridays than any other day of the week.
- More crashes happened during the 5:00 p.m. hour than any other time of the day.
- More than half (64.2%) of serious/fatal crashes happened during clear weather conditions, and most (76.2%) happened on dry roads.
- Almost half (48.5%) of serious/fatal crashes happened during daylight hours, opposed to dawn/dusk, night, and unlit roads.
- The top three months for serious/fatal crashes were March, May, and July.





The Traffic Safety Program aims to educate and foster better habits for drivers, pedestrians, and bicyclists through its outreach initiatives, including new events in 2023:

- Buckle Up Batter Up in partnership with Ohio State Highway Patrol and the Toledo Mud Hens, this event honored more than 20 people who were Saved by the Belt in local crashes.
- Car Care and Facts Fair Brought resources to the community with more than
  15 booths educating drivers on various vehicle and driving safety topics. These
  included how to change a tire, intoxication simulation goggles, how to act and
  what information to provide when law enforcement pulls you over, and car
  seat safety.




In 2023, the Toledo-Lucas County Health Department put significant effort into addressing the spread of syphilis within the eight county region of Northwest Ohio.


We continued our partnership with the University of Toledo's Ryan White Program, a service that provides guidance to healthcare professionals who work directly with patients diagnosed with syphilis.

We continued our billboard campaign to spread awareness and call community members to get tested for syphilis.









Toledo-Lucas County Health Department's 60+ nurse partners with the Area Office on Aging to visit local senior centers.


















# CHILDREN WITH MEDICAL HANDICAPS

The Children with Medical Handicaps Program (CMH) is a health care program through the Ohio Department of Health, linking families of children with special healthcare needs to a network of quality providers, and helps families pay for services their children need.

Through the Diagnostic Program, families receive medical services to rule out a special health care need, diagnose a condition, or develop a plan of treatment. If a diagnosis is made that requires treatment, the family is referred to the Treatment Program, which can help with the costs of surgeries, medication, medical supplies, and therapies. Families must financially qualify for the Treatment Program.

Participants can be enrolled in the CMH Diagnostic Program until age 21, and the Treatment Program until age 24.

# 2023 YEAR IN REVIEW JUNE 15, 2023 POINT PLACE TORNADO

On June 15, 2023, several tornadoes touched down in Northwest Ohio. One of the hardest hit areas was Point Place in Lucas County. There was a lot of wind damage with trees down and power outages.

Jeffrey Boamah, REHS for the Point Place district, and Keianna Wimberly, REHS were sent to the area to assess damage and educate food operations on how to handle a power outage, including keeping food safe while power was out and determining what food would need to be discarded.

Power was not restored until Sunday, June 18, 2023, and some facilities that sustained damage did not open until later the following week.



### **ACADEMIC PUBLIC HEALTH**

The Toledo-Lucas County Health Department first established an Academic Public Health Department (APHD) in 2022 to foster more robust partnerships with local colleges, universities, and other schools, and to promote the development of the next generation of public health professionals. APHD staff also work closely with Human Resources to promote, establish, and offer workforce development opportunities for current TLCHD staff.

Throughout 2023, TLCHD's APHD has been regarded as a promising practices model by public health peers, with APHD staff informing on the successes and barriers of our implementation and methods, and speaking at conferences hosted by the National Network of Public Health Institutes, the American Public Health Association, and the Ohio Environmental Health Association.



Among the biggest accomplishments in 2023, the APHD reached **604 students** through direct student experiences and various career fair, classroom, clinical rotation, and presentation events. This is a **47.8% increase** in students reached from 2022. Likewise the total hours for student experiences increased 123.7% to **2,837.35 hours**, almost entirely through direct experience internships.

In addition to future public health professionals, the APHD has fostered training and reimbursement opportunities for current staff through TechCred and the Association of Ohio Health Commissioners (AOHC) tuition reimbursement initiatives.



# **QUALITY IMPROVEMENT**

#### **Quality Initiatives**

- In 2023, TLCHD undertook a comprehensive assessment of its programs and services to clearly define the success state, scope, resources, and targeted audiences for each.
- TLCHD became a FIMR (Fetal Infant Mortality Review) mentoring site in February 2023, recognized by the National Center for Fatality Review and Prevention, and the National Healthy Start Association. TLCHD's recognized epidemiologist mentored one internal and one external epidemiologist in 2023.
- The Epidemiology program developed and published a medical practitioner resource webpage to serve as a single focus point for practitioners that need information on how to report Class A, B, or C infectious diseases, when to report, and additional considerations to be made.
- The Epidemiology program collaborated with the Food Services program to improve the manner in which food-borne illness and food facility complaints are received from the public and handled internally. The new Food Safety & Illness Reporting survey supplements updated protocols and now sends complaints received directly to the correct internal department for follow-up.

#### **Community Health Assessment**

TLCHD, as part of the Healthy Lucas County Coalition, participated in the development and release of the 2022/2023 Community Health Assessment (CHA) in December 2023. The CHA provides a snapshot of the health and well-being of children ages newborn to 11, youth ages 12-18, and adults throughout Lucas County. This assessment identifies key health needs and issues through systematic, comprehensive data collection and analysis. The CHA is conducted and released every three years to help hospitals, public health, schools, and many other organizations prioritize and address the health needs of Lucas County residents. #### **RAND**

TLCHD partnered with the RAND Corporation and Robert Wood Johnson Foundation for the next phase of the **Sentinel Communities Surveillance Project**. The primary goal of this effort is to understand the ways communities have been working toward improving health, equity, and well-being for residents, and the barriers that may exist in these efforts. Toledo is one of 30 communities across the U.S. (and the only city in Ohio) chosen for this project's 10-year effort to build a culture of health in America in 2016. This work will continue in 2024 with additional key stakeholder discussions and workshops.
