Pursuant to the Ohio Administrative Code 3701-36-14 and Ohio Revised Code 3709.09 the Toledo-Lucas County Health Department has completed the annual calculation of license fees for Body Art Operations. ***This letter is for informational purposes only.***

Below are the 2025 proposed fees for Tattoo & Body Piercing Operations listed by type of services.

*Each business operating as a Time Limited Event is required to apply for and pay for this license.

Time Limited Body Art events will require each artist/booth to submit and pay for the Time Limited Body Art license. This change is according to the Ohio Administrative Code 3701-9-01 (J), Ohio Administrative Code 3701-9-03 (A)(4), and Ohio Administrative Code 3701-9-02 (J).
