
#### Call to Order & Welcome- Tony Dible, Toledo-Lucas County Health Department

#### 1. Announcements & Introductions

- Review of overdose and fatality statistics within African American population
  - o Represents 26% of fatal overdoses in 2022
  - o 26% of overdoses that TFRD responded to were within AA community
  - o 26% of Narcan kits distributed in 2022 given to AA residents

#### 2. Opioid Settlement Funds – Scott Sylak (MHRSB)

- Scott sits on OneOhio Recovery Foundation State Board
  - Matt Bell is the current chair of our region 4 board
- State divided into 19 regions, Lucas County is their own region region 4
- OneOhio MOU
  - Governing rules for all entities overseeing the funds. Must read if any agency intends to apply for funding
- Division of Ohio's settlement funds
  - o 30% to local government
  - o 15% to the State
  - o 55% to OneOhio Recovery Foundation
    - They will have 90 days to decide how it will be dispersed
- Time of Settlement: 19 years
  - Point of Discussion: should a portion of the funding be invested to allow extension of the funding past the 19 year plan
  - o Lucas County's cut: approximately \$2.3 million
  - o Structure of funding leans heavier in first few years than in later years
- Each region can recommend to the State Board which entities will receive funding. After review from the Foundation, recommendation will be reviewed by an expert panel.



## Lucas County Opiate Coalition Meeting

- akoyaGO chosen by OneOhio Recovery Foundation as the platform for creating statewide application for funding
  - When applying, initial screening at state level, then screened at the local level.
  - Training for akoyaGO will be available for each region
- If Region 4 does not spend all of the funds allocated for each year, it stays in a pool for future years within the same region.
- Likely that money locally will begin to flow late this summer, into fall

#### 3. Operation Engage – Wendie Jackson (DEA)


- 23 DEA divisions in the nation. DEA Detroit covers all of MI and OH


- MHSRB Scott Sylak
  - o Issue 8: 1 mil additional levy for MHSRB, only a net gain of 0.5 mil
    - March 19th primary
    - \$100k homeowner pays \$35 per year, is ultimately \$2 a month more per homeowner
    - One of the focuses: Improved treatment in Correctional Facilities
    - Issue8.com
- Dr. Gombash
  - Wanted to highlight the myth, recently propagated by the Blade, of fentanyl leading to overdoses in street marijuana
- HIV / Syphilis, TLCHD Donna Fox
  - Our 8 county NW Ohio region is nearing outbreak status for syphilis.
    - New Cases per year: 183 (2021), 160 (2022), 186 (2023)
    - For comparison, in 2011, we only recorded 19 new cases.
  - Encourages relevant programs to provide testing or screening on site. Donna and TLCHD are a resource for any program, and has educational materials to distribute for clinics.
  - 29% co-infection rate in 2022 with HIV and Syphilis










Age Breakdown










## PARTICIPATION

In 2023, NOSS saw a 21% increase in participation, helping 927 unique individuals access sterile drug use supplies, overdose prevention tools, disease and pregnancy testing, and referrals to services such as housing, food pantries, treatment, and medical services.


