2. Coalition Committee Updates

- Steering Committee
 - i. Reintroducing members and purpose

 - Purpose: Leadership body of Coalition, charged with guiding the direction for the Coalition.
 - ii. Seeking new members

- Public Safety
 - i. DART Year to Date 2025
 - DART has served 204 new clients, responded to 36 overdoses at hospitals, engaged in 1,510 interactions, provided 52 referrals to treatment, and physically connected 171 people to treatment.
 - DART family support group 1st and 3rd Monday of month at Aldersgate United Methodist Church.
 - a. 21 meetings in 2025 with 98 attendees.
 - Participated in 12 community events, reaching 2,147 people.
 - Client demographics.
 - a. Most clients are 25 44 years old.
 - b. $\sim 60\%$ males, $\sim 40\%$ females.
 - ii. ONEbox Naloxone Emergency Box
 - DART is launching an initiative to distribute free ONEbox wall mounts for naloxone to hotels, businesses, churches, treatment facilities, etc. Reach out to Steve with DART if interested.
 - Benefits: purple box with verbal instructions on how to administer naloxone, has option for multiple languages.
- Public Health TLCHD
 - i. From July August 2025, all partners distributed:
 - 4,887 naloxone and ~12,800 fentanyl test strips.
 - ii. Gov. DeWine recently decriminalized testing strips for xylazine, medetomidine, benzodiazepines, and nitazenes. The hope is that the State will begin to provide these resources to local communities.
