**The following information must be provided on page 2 of this application, on a separate sheet or on the required site plan.**

- The number of livestock being kept on site
- A description of the livestock shelter. For example, list the material the shelter is made out of. Provide a picture of the shelter (optional).
- Provide a picture of the yard to show the placement of the shelter (optional).
- Provide a picture of the outdoor area the livestock will have access to (optional).
- Type of feed storage containers and note where they will be located.
- Describe how the livestock will be fed to not attract pests to the property.
- Describe how the manure, bedding and any other waste will be handled.
- Describe any other relevant information regarding the request for a permit from the conditions described in Toledo Municipal Code Section 1705.05

#### **Site Plan Requirements**

- Please see the following page for example of site plan
- Show a North arrow and scale on the site plan (Example- 1 inch = 20 feet)
- Show property lines with exact dimensions of the lot labeled
- Show the exact dimensions and locations of all existing buildings (house, garage, shed, barn, etc.), structures (pools, decks, patios, etc.) and driveways and access points. Indicate setback distances of each from the property line with measurements/distances labeled.
- If your property has a well or septic system, show exact location on site plan
- Show the location of the shelter with all setback distances from the property lines. If you will be using a portable shelter, indicate the yard area where the structure will be kept.
- Show all fence locations
- Applicant may use AREIS Online database (Auditor's Real Estate Information System) to help with property lines, acreage, etc. <http://maps.co.lucas.oh.us/areis/areis.asp>



### Toledo Municipal Code Section 1705.05 - Keeping of Livestock

*"No person shall raise or keep any hogs, cows, goats, geese or ducks, or any number thereof, within the corporate limits of the City, without having first obtained a written permit from the Commissioner of Health to so keep such hogs, cows, goats, ducks or geese, or any number thereof, and such permit may at any time be revoked by such Commissioner of Health, provided that when such permit is granted, such hogs, cows, goats, geese or ducks, or any number thereof, shall be kept upon and within the confines of the premises of the owners of such hogs, cows, goats, geese or ducks."*

### Toledo Municipal Code Section 1705.07 – Nuisance conditions prohibited

*"No person shall keep or harbor any animal or fowl in the City so as to create noxious or offensive odors or unsanitary conditions which are a menace to the health, comfort or safety of the public."*
